Globally, conflicts and insecurity are multiplying, continuously generating new humanitarian needs. Conversely, the resources allocated by major international donors, instead of increasing, are decreasing: today, funds fail to cover 50% of requirements. This apparent contradiction is actually the result of a profound cultural shift. The traditional model of development cooperation is currently being strongly questioned: the idea that shared development generates benefits for all is declining, while the "Trade over Aid" paradigm, which privileges commercial partnerships as a tool for development, is advancing.

In this complex and constantly evolving framework, COOPI firmly confirms its mission: this report bears witness to our commitment in emergencies – which have grown in number and severity in recent years – and to the promotion of equitable and lasting development.

We have operated in contexts of severe humanitarian crisis – including Sudan, the Democratic Republic of the Congo, Gaza and Lebanon, Venezuela – strengthening emergency interventions and facilitating the transition towards development by reinforcing community resilience and social cohesion.

In Italy, we have further developed our activities to combat poverty and begun to outline a greater articulation of our intervention.

The contraction of available resources has forced difficult choices – including the downsizing of Regional Coordinations and the suspension of activities in some countries – yet COOPI has not lost heart: its main strengths have been, once again, competence, operational flexibility and the ability to network at all levels, from the strategic to the operational, from the local to the international dimension.

This is certainly a complex moment, which has already required sacrifices and will require more, but it can also be an opportunity for evolution for COOPI and for the entire international cooperation sector, in which to rediscover common values and an authentic spirit of sharing.

COOPI – Cooperazione Internazionale is a humanitarian organisation that for **60 years** has been committed to fighting **against all forms of poverty** and accompanying populations affected by wars, socio-economic crises or natural disasters to exit from crises and launch processes of recovery and **lasting, sustainable development**.

COOPI today is a foundation present in **30 countries** in Africa, the Middle East, Latin America and the Caribbean, with **194 humanitarian projects** reaching more than **7.5 million people**.

COOPI works with an **integrated approach** in situations of **humanitarian crisis and development** by promoting food security and nutrition, water and hygiene, health, protection and education.

To give more effective and structured responses to the needs of people in difficulty and in order to **actively involve beneficiaries** in decisions and activities, COOPI plans its interventions at a **regional multi-country level** and has chosen with conviction the model of **organisational decentralisation**, which provides for the reduction of distances between planning, decision and action, and the development of **local partnership** relations, to further strengthen development at the local level and improve the living conditions of beneficiary communities.

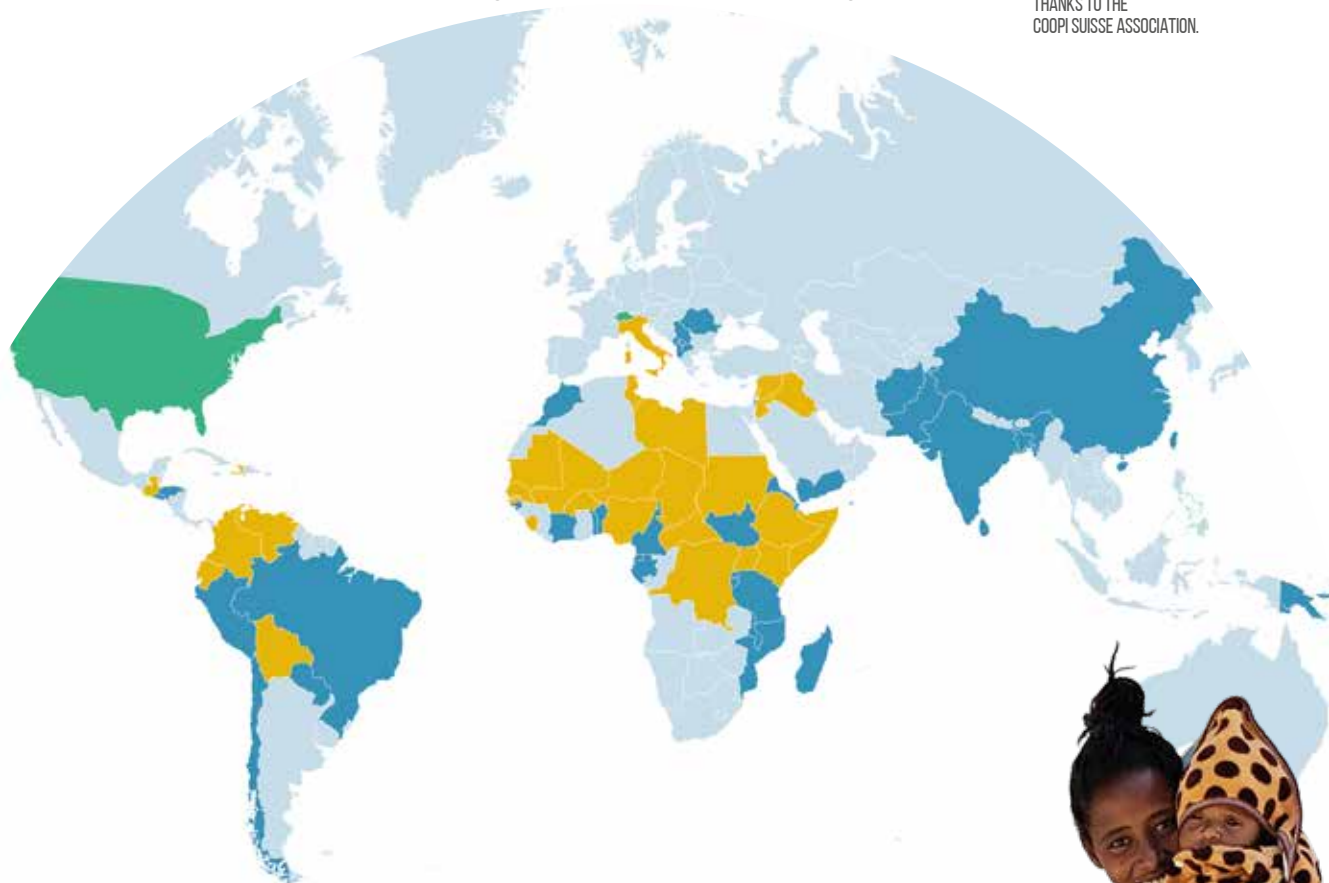

COOPI'S IMPRINT

In 2025, COOPI was present in **30 countries** across Africa, the Middle East, Latin America and the Caribbean, and Italy. In 29 of these countries, it carried out a total of **194 projects**, of which 177 were emergency and development projects and 17 were Child Sponsorship projects. In total, the number of **beneficiaries** reached was **7,521,203**.

In 2025, COOPI was also present in Kenya, maintaining active relationships with stakeholders at different levels.

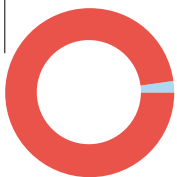

COOPI DEVELOPMENT LINES: “THE NEAR FUTURE”

The **COOPI Development Lines** – summarised in the document “*The near future*” – highlight right from the start what the first objective is and, at the same time, the element that makes COOPI's way of operating and creating impact for communities specific and recognisable: the concept of “nearness”.

“**Near**” understood as **our neighbour**, concerning those who find themselves in conditions of fragility.

“**Near**” as in those closest to us and who may need support even if they are “far away” from typical first and third world logic.

“**Near**” as in the near future, what will happen or, even better, is already happening.

In a global scenario that sees the multiplication of emergencies - which are becoming more frequent, more locally circumscribed and more complex to decipher from the point of view of the actors involved - COOPI delivers **humanitarian action** interventions and promotes - in all contexts where it is possible - the **evolution of interventions on the ground from emergency responses to processes for the promotion of lasting and sustainable development**, a characteristic that has always distinguished its work and whose value is increasingly recognised also by major international donors.

WITH THE DEVELOPMENT LINES “THE NEAR FUTURE”, COOPI HAS CREATED A GUIDELINE DOCUMENT THAT IS FIRST OF ALL A **WORKING TOOL**. FOR THE PERIOD 2022-2024, COOPI IDENTIFIED **6 STRATEGIC OBJECTIVES** FOR ITS DEVELOPMENT:

In 2025, COOPI launched a process to **update its Development Lines**, which will lead it during 2026 to focus on the further stages of evolution of the organisation to support an increasing number of people in emergencies with timeliness and competence, and to **combat the different forms of poverty** in an increasingly effective, systemic and inclusive way.

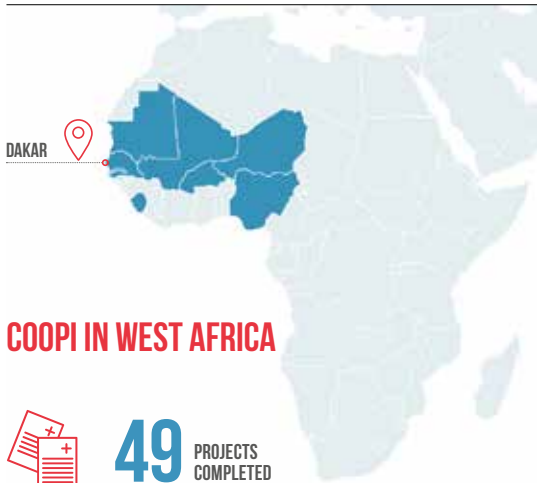

In West Africa, COOPI implements **integrated management of humanitarian crises** accompanied, in all cases that allow it, by activities to consolidate **community resilience**. In each area of intervention, COOPI plans and implements activities in collaboration with **local institutions and partners** starting from a **regional vision**: projects carried out at the national level are not isolated, but fit into a broader framework that takes into account active and/or possible projects in neighbouring countries. Depending on the context in individual countries, interventions are carried out for first-emergency management, in the **health** sector - with a focus on **mental health** -, to combat **food insecurity and malnutrition**, for the **protection** of the most fragile and for **education**. In the post-emergency phase - in accordance with the principles of a Nexus approach - COOPI is committed to facilitating paths to **peace and social cohesion**, strengthening the **resilience of local communities** and promoting paths towards **sustainable and lasting development**.

For over half a century, COOPI has operated in **Central Africa** with the aim of expanding **access to essential services**, consolidating the **resilience** of local communities and promoting **peaceful coexistence**. In the region – depending on the context – the organisation gives priority to programmes aimed at combating **malnutrition** and ensuring **food security**, as well as **education**, **protection** and the **promotion of social cohesion**. In response to the worsening crisis in the Democratic Republic of the Congo and the influx of internal displaced persons and Sudanese refugees into the Central African Republic and Chad, COOPI has intensified its emergency **humanitarian assistance** activities in the area. Every initiative is developed in synergy with state authorities and local organisations, ensuring the direct involvement of the beneficiary populations.

For over forty years, COOPI has maintained a consolidated presence in Eastern and Southern Africa, intervening with **humanitarian assistance** actions in response to crises resulting from conflicts, climate emergencies and natural hazards. The organisation's action is structured through multi-year programmes aimed at integrating **basic services** — such as access to **water** and **sustainable energy** sources — and combating **food insecurity**, promoting **social cohesion** to strengthen community resilience.

The operational approach in the region is aimed at facilitating the **nexus between emergency** and development, ensuring systemic coordination with **local institutions** and **partner organisations**. Through a decentralised governance model, COOPI guarantees programming on a regional scale capable of adapting with flexibility and precision to the specific local demands identified in the field.

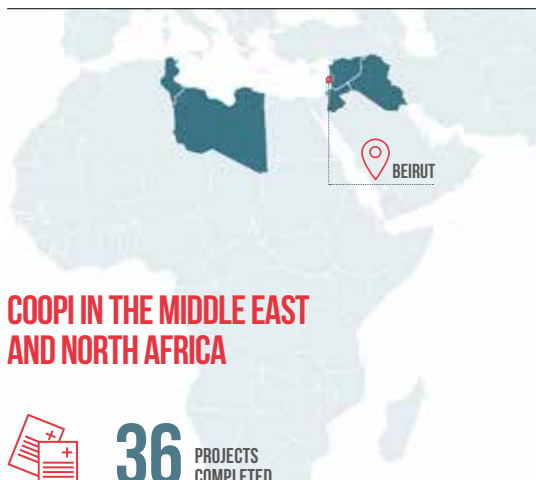

MAIN AREAS OF REGIONAL INTERVENTION



In the **Middle East**, COOPI's action focuses on the restoration of essential services and the promotion of livelihoods, which are indispensable conditions for ensuring dignity and stability for populations. The projects carried out are in many cases multi-sectoral and focus primarily on **humanitarian assistance, protection and education in emergency management contexts**, while focusing on **WASH, food security and economic development** in post-emergency contexts. In **North Africa**, the intervention mainly supports local institutions in guaranteeing **basic services in Libya**, and promotes **job opportunities** and social inclusion for the population in **Tunisia**. In the field, COOPI always promotes listening to and directly involving the communities in which it operates, implements strong synergy with **national and local institutions and partners**, and promotes a process of progressive **localisation**.

COOPI's action in Latin **America and the Caribbean** develops through multidisciplinary interventions, aimed at strengthening the resilience of populations by integrating humanitarian assistance, **reconstruction and medium-to-long-term actions with a particular focus on sustainable development**. The priority in the region concerns **support for migrants**: COOPI carries out **humanitarian assistance** interventions guaranteeing **protection**, access to **health services**, and **psychological and legal assistance** to refugees, migrants and displaced persons. The organisation is also very active in carrying out interventions that guarantee **access to clean water** and **sanitation services** and adequate **waste management** - including through **circular economy** projects - with the dual objective of protecting the environment and promoting social inclusion. The commitment extends to **combating food insecurity**, providing communities with the tools for self-sufficiency and supporting **participatory governance models** based on respect for fundamental human rights. In key territories from an environmental point of view - such as Colombia, Ecuador, Peru and Bolivia - COOPI works for the **preservation of forest ecosystems**, collaborating closely with civil society realities and native populations.

Every month, COOPI is committed to assisting more than 2,000 people in difficulty in Milan, a number that has almost tripled since 2020. In some of the neighbourhoods with the highest concentration of vulnerable people, COOPI distributes food bags to single women with their children, the elderly, and families struggling to make ends meet.

To respond to the increase in demand, COOPI has expanded the project over time: food aid distribution points have been opened, which also serve as first-listening centres. COOPI joined the QuBi Network for fighting child poverty and subsequently – with the Space in Piazza Selinunte – it became one of the Food Policy **Hubs against Food Waste** in Milan.

In the coming years, COOPI intends to continue, in a network with other entities active in the territory, its commitment to fighting poverty in Italy, both through food distribution and first-listening activities - in Milan and urban areas - and by contributing to promoting **development initiatives in marginal and disadvantaged areas** of the country.

POLICIES AND GUIDELINES

The Policies and Guidelines illustrate the organisation's positioning on the topics covered, starting from the definition of the international theoretical reference framework. COOPI's interventions in the field are based on certain principles, which are then articulated in the various sectoral Policies and Guidelines:

- RECOGNISE THE **CENTRALITY OF THE INDIVIDUAL** BY RESPECTING OTHER'S IDENTITY, SOCIAL AND PHYSICAL CHARACTERISTICS AND ENSURING THE **PROTECTION OF HUMAN DIGNITY**;
- DETERMINE THE INTERVENTIONS ON THE BASIS OF AN ANALYSIS OF THE **CAPACITIES AND VULNERABILITIES OF THE COMMUNITIES**;
- ADOPT **INCLUSIVE DECISION-MAKING PROCESSES**;
- PROMOTE **CAPACITY BUILDING** AND **KNOW-HOW TRANSFER**;
- GUARANTEE **PROTECTION FROM VIOLENCE** IN ALL ITS FORMS;
- PROMOTE **GENDER EQUALITY**;
- PROTECT THE ENVIRONMENT TO PROMOTE **SUSTAINABLE DEVELOPMENT**, INCLUDING THROUGH WIDESPREAD ACCESS TO SUSTAINABLE ENERGY AND DISASTER RISK REDUCTION PROGRAMS (DRR).

Each COOPI's sectoral **Policy** has a dual objective: to help the organisation discuss the central issues for its programmes in order to share and agree on a working approach, and at the same time to clarify and make known the institutional position with respect to the various topics covered. The policies therefore complete the values, the vision and the mission by articulating in more depth the working methods and the strategy underlying the programmes defined by the organisation.

Furthermore, in conjunction with each policy document, a **Standard Operating Procedures** document is drawn up that translates the theoretical into the practical for programme management, while accompanying the workers who implement it in order to make the interventions sustainable and effective.

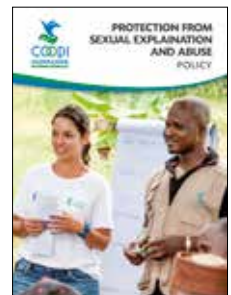

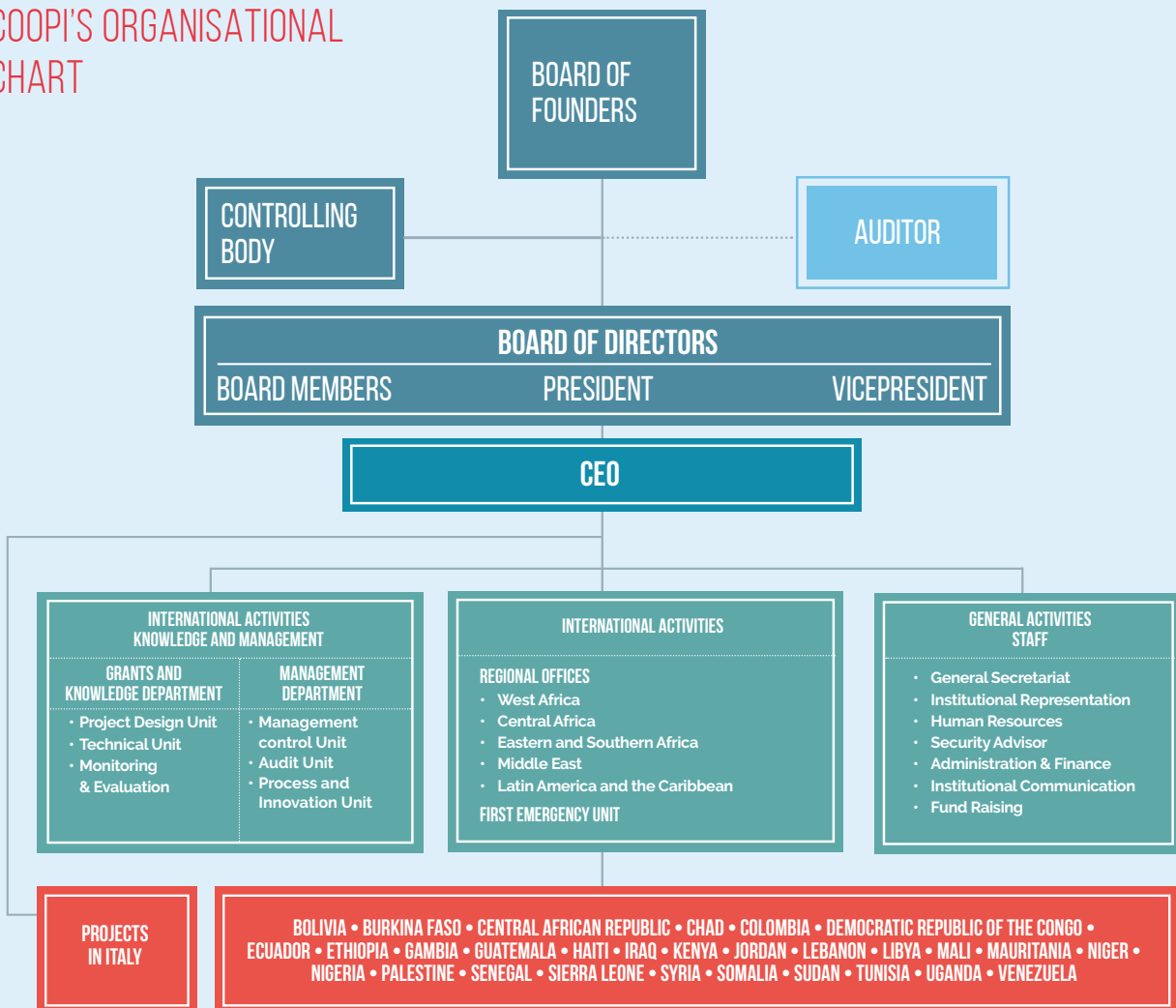

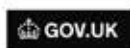
SUPPORTERS

COOPI HAS BEEN WORKING WITH INSTITUTIONAL DONORS FOR MORE THAN FIFTY YEARS.

The organisation's activity relies significantly on funds from institutions and organisations - such as, among the main ones, the **Italian Cooperation (AICS)**, the **European Commission** or **UN Agencies** - which evaluate and select international cooperation projects they consider most effective for funding.

The COOPI *modus operandi* combines a **strategic vision** with a **strongly pragmatic approach**, oriented towards **maximising the effectiveness** of field interventions and guaranteeing **maximum transparency**. Over time, the organisation has developed a strong capacity for context analysis and planning — both at country and regional level — and has adopted timely reporting tools: elements in line with the institutional donors' need to collaborate with organisations that thoroughly know the communities in which they operate, capable of developing coherent intervention programmes and demonstrating produced results and achieved changes in a very specific manner.

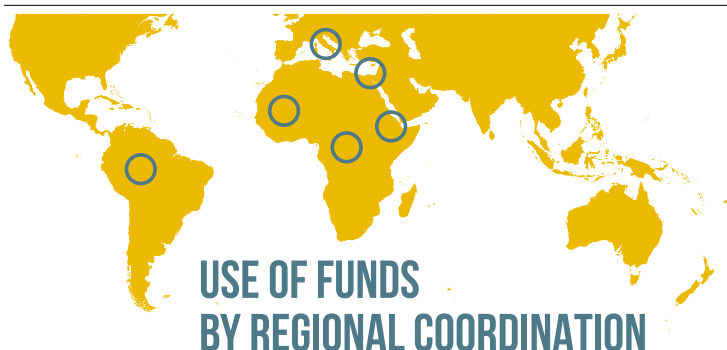

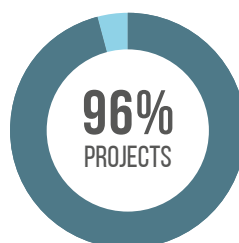
USE OF FUNDS BY SECTORS OF INTERVENTION
